


Coastal Armoring

Major Accomplishments

- Southern Monterey Bay Coastal Regional Sediment Management Plan, 2009
- Evaluation of Erosion Mitigation Alternatives for Southern Monterey Bay report, 2012
- Draft Coastal Regional Sediment Management Plan for Santa Cruz Littoral Cell, 2015

 Coastal Armoring

- Relevant, requires some revision, particularly with regional approach
- Finalize 2015 CRSM Plan
- Implement strategies in both Monterey and Santa Cruz CRSMP's




Desalination

Major Accomplishments

- Developed NOAA's Guidelines for Desalination Plants in MBNMS, 2009
- Completed a final EA and FONSI for California American Water test slant well project at CEMEX site in Marina & authorized the Coastal Commission Coastal Development Permit
- Completed a new web page on Desalination Projects in Monterey Bay
- Will serve as Federal lead for NEPA on 2 current projects

- Largely still applicable, revisions needed for modeling and monitoring
- Continue to apply NOAA guidelines to citing desal facilities in MBNMS






Harbors and Dredge

Major Accomplishments

- Harbor and dredge disposal permit process streamlined
- Consulted on Elkhorn Slough sill reducing sediment erosion, protecting marsh
- Annual reviews for harbor dredge disposal is an ongoing process

- Plan is entirely relevant as is
- Coordinate with USACE, GFNMS, and Surfer's Beach stakeholders on pilot beach nourishment project
- Continue to coordinate with harbors on dredge disposal activities



Submerged Cables


Major Accomplishments

- Submerged cable permit guidelines developed
- Environmentally sensitive areas in sanctuary identified

Submerged Cables




Big Sur

Major Accomplishments

- Improved interagency communication with Caltrans, State Parks,
 Forest Service, etc. for major events (fire, slides, etc.)
- Assessed rocky shore and subtidal ecology impacts of the Alder Creek Slide via 3-year study
- Continued to attend the Big Sur Multi Agency quarterly meetings

- Much of the plan is no longer relevant or requires major revision
- Continue coordination with Caltrans on landslide disposal
- Update GIS Sensitivity Index, which is used for management decisions during emergencies



Bottom Trawling and Effects on Benthic Habitats Major Accomplishments


- Characterized the continental shelf between Piedras Blancas and Big Creek.
- Assisted with CSUMB and TNC led study, "Central Coast Trawl Impact and Recovery Study: 2009 - 2012." (in partnership with fishermen)
- Submitted Collaborative Proposal to Pacific Fishery Management Council to request modifications to Groundfish Essential Fish Habitat, 2013
- Identified Sanctuary Ecologically Significant Areas (SESAs), 2013

Looking Ahead

- Much of the plan is relevant but requires differing levels of revision
- Continue to track PFMC process for Groundfish EFH modifications

Bottom Trawling and Effects on Benthic Habitats




Davidson Seamount

Major Accomplishments

- Identified as one of the better explored seamounts in the world
- Identified as one of the best protected seamounts in the world
- Davidson Seamount Management Zone management plan developed
- Taxonomic Guide completed, including 6 species new to science
- May 2015 Cruise planned on NOAA R/V Shimada

 Replace this plan with the Davidson Seamount Management Zone plan




Emerging Issues Major Accomplishments

- Influencing USCG regulatory changes on lost shipping containers (IMO)
- Developed and implemented 2 regional workshops on climate adaptation in collaboration with Center for Ocean Solutions and local agencies.
- Issues identified in plan are escalating and being tracked/addressed (desalination, elephant seal expansion, micro-plastics, climate adaptations)

- Continue work on lost shipping containers, climate adaptation, etc.
- Update list of emerging issues




Introduced Species

Major Accomplishments

- Characterized, monitored, and attempted to manage spread of *Undaria*, and *Watersipora*.
- Promulgated regulation banning invasive species in federal waters.
 Final rule March 2015

- Update entire action plan
- Continue to coordinate with NOAA, National and Regional Aquatic Nuisance Species group




ECOSYSTEM PROTECTIONSIMoN

Major Accomplishments

- MBNMS Monitoring priorities identified
- MBNMS Condition Report, assessing resources of the MBNMS
- Robust SIMoN web site (expanding to include CINMS)
- Over 130 research groups provide monitoring information to SIMoN

- Much of the plan is relevant and ongoing in nature
- Revisit funding mechanisms and the feasibility building it out for all sites




Marine Protected Areas

Major Accomplishments

- Phased MPAs process into Sanctuary Ecologically Significant Areas (SESAs) development
- Established non-regulatory Sanctuary Ecologically Significant Areas
- The Natural Resources of Monterey Bay National Marine Sanctuary: a focus on federal waters, 2013

Collaborated on MPA SCUBA surveys and continental surveys of State MPAs

- Complete revision of action plan to⁵ focus on implementing SESAs
- Continue MPA SCUBA surveys



OPERATIONS AND ADMINISTRATION


Operations and Administration

Major Accomplishments

- Robust, safe dive operations detected sea star wasting syndrome
- Active and engaged Sanctuary Advisory Council
- Robust permit process w/ continued streamlining
- Established Law Enforcement Tactical Advisory Group (LETAC)
- Over 1,00 volunteers trained, enriched and recognized since 2009


Major Accomplishments


Fishing Related Education and Research Major Accomplishments

Sea Grant Fellow (community supported fishery)

- A profile of the hook and line fishery for California Halibut in Monterey
 Bay, California: learning from fishermen through collaborative research study
- Voices of the Bay and Fisherman in the classroom programs developed
- Fisheries exhibitry and signage

- Much of this plan has been completed or well underway
- New emphasis needed for communication between fishermen and researchers

Interpretive Facilities


Major Accomplishments

- Sanctuary Exploration Center constructed and operational
- Coastal Discovery Center exhibits updated
- Signage Inventory updated (36 signs installed sanctuary wide interpreting wildlife viewing practices)
- New MBNMS website
- Social media implemented




PARTNERSHIPS AND OPPORTUNITIES

Ocean Literacy and Constituent Building Major Accomplishments

- Robust Volunteer programs
- Quality Classroom and informal education programming (> 12,000 students through MERITO, Centers, in-class and special programs)
- 14 years of MERITO programming: students, teachers, interns & communities
- 25th Currents Symposium (research topics in Monterey Bay), CSUMB now leads

- A large number of actions initiated, but many require revision of some kind
- Refine focus of K-12 programming and Business Outreach
- Strengthen organization of volunteer programs



WATER QUALITY

Beach Closures and Microbial Contamination

Major Accomplishments

- First Flush and Urban Watch programs data collection & public engagement
- 15 Years of Snapshot Day data collection & public engagement
- Millions in grant money to local cities based on WQPP data

- Keep plan largely as is w/ some minor revision
- Monitoring is ongoing in nature and is important to continue




WATER QUALITY

Cruise Ship Discharges Major Accomplishments

- Coordinated unscheduled, random USCG/NOAA inspections of cruise ships
- No MBNMS discharge related violations detected once prohibitions in place.
- Cruise lines initiated internal guidance and operational compliance materials for crew while in MBNMS and other NMSs

Looking Ahead

- Most of this plan will require revision
- Continued collaboration with City of Monterey and USCG



Cruise Ship Discharges


WATER QUALITY

Water Quality Protection Program Implementation

Major Accomplishments

- Draft Plan for a region-wide water quality monitoring program developed and supported by coastal jurisdictions
- Central Coast Action Tracker portal developed
- Coordination and participation in Agriculture Water Quality Alliance

- Keep largely as is, with revisions to regional monitoring, access to data and areas where harbors and municipalities have taken the lead
- Major revisions suggested for activity related to wetland and riparian areas



WILDLIFE DISTURBANCE


Marine Mammal, Seabird, and Turtle Disturbance

Major Accomplishments

- Team OCEAN program (14th season, >81,000 contacts, 15,000 hrs)
- Bay Net shoreline interpretation program (130,000 contacts, 8,500 hrs)
- Revisions to FAA charts now include NOAA over flight zones
- Primary responder for whale entanglement issues
- Lost fishing gear removal cruises (2009, 2010, 2012)
- Developed method for monitoring maritime industry compliance
- ONMS Noise Working Group participation

Looking Ahead

 Some portions are still very relevant with revisions required for enforcement, acoustics, sea turtles and impacts from commercial harvest.




WILDLIFE DISTURBANCE

Motorized Personal Watercraft

Major Accomplishments

- Created Mavericks conditional seasonal zone
- Created and administered permit system for official use by public safety agencies
- Developed and implemented standard conditions for permitting paddle-in contests utilizing MPWC for safety purposes

- Large portions of this plan have been^{5.5} completed or remain relevant
 (outreach, zone maintenance)
- Training of public safety personnel will require revision




WILDLIFE DISTURBANCE

Tidepool Protection

Major Accomplishments

- Coordinated with PISCO monitoring
- Created and installed tidepool etiquette signage
- Coordinated LiMPETs Program, now with PG Museum of Natural History
- Conducted MERITO school field programs Tidepool

- Much of the action plan is not yet initiated but parts are still relevant
- Major revision required
- Assess what is necessary for MBNMS vs. other agencies



CROSS-CUTTING ACTION PLANS

Maritime Heritage


Major Accomplishments

- USS Macon wreck site characterized
- USS Macon accepted into the National Register of Historic Places
- Oil tanker Montebello surveyed in detail, at depth, and determined not to be an oil spill hazard.
- Outreach materials and web pages developed for both wrecks
