

Purple urchins (Stronglyocentrotus pupuratus) transformed many Monterey and Carmel kelp forests into urchin barrens. Beginning in 2014 observed populations of purple urchins have increased significantly and giant kelp densities have decreased significantly. Openly grazing purple urchins can live for more than a year without eating, can eat from the water, and recruit urchin larvae to the hard substrate. Urchin barrens are considered a decadal alternative stable state, meaning they could last for more than 10-*years. (These statements remain undisputed). There are ongoing efforts in Southern California and Northern California to clear some of the impacted areas. This effort is not meant to change the issue but to mitigate small areas in an effort to retain some of the displaced marine species normally found in our local kelp forests until more science leads the Marine Life Professionals to clearer answers. 




