- Steve presented highlights of MBARI research, including:
- Monterey Accelerated Research System (MARS; Contact: Craig Dawe)
- Utilizing UCSC's vessel R/V Paragon for mooring maintenance, blue water diving
- Long-range AUV Tethys, deployed off small boats, longest trip 1800 km
- Mooring/Sensors in Elkhorn Slough (nitrate, pH; Ken Johnson)
- Development of coastal profiling float, replacement for ARGO array (Ken Johnson)
- Monitoring of chemical weapons sites using mapping AUV (Peter Brewer) off S.F. and Santa Cruz Basin (So Cal)
- MBARI video lab (main video data stream): Characterization of bio, geology, habitat, and experimental procedures using VARS; several projects with MBNMS (Davidson Seamount, Sur Ridge, USS Macon, lost shipping container, SESAs, Sanctuary Exploration Center)
- Field tests for low cost self-contained camera (go-pro) for autonomous imaging and timeseries
- Whale falls, cold seeps (Vrjenhoek Lab)
- Midwater ecology lab (Bruce Robison): characterize deep pelagic fauna, and develop a baseline
- Zooplankton biodiversity and bioluminescence (Haddock Lab)
 - o Jellywatch.org doing well; mobile app; continuing to expand program globally

SANCTUARY ADVISORY COUNCIL UPDATE

Summary of February 21st SAC Meeting at Pacific Grove (Lindholm)

- Lindholm provided overview of SAC meeting
- Information Item: Leatherback Sea Turtle Summit, and international partnership with Indonesia (SAC Conservation Working Group)
- Information Item: Understanding and reducing the impacts of underwater noise in marine protected areas (Leila Hatch, ONMS); ONMS will look at this issue nationally rather than at individual sites; SAC wants to learn more on sound issue (natural vs human-caused)
 - RAP Membership committee will meet to discuss potential acoustic RAP discipline/member (NPS volunteer)
- Information Item: Update on MLPA Central Coast Monitoring Effort (Liz Whiteman, Ocean Science Trust)
 - o Central coast next for monitoring (funding opportunity unclear)
 - o New monitoring plan and indicators on the horizon
- Pacific Fisheries Management Council addressing drift gill net issue at March meeting; fishermen want less drift gill net closures (seasonal at Davidson Seamount vicinity), conservation group wants to keep closures/ban (concerned with leatherback sea turtles and other); state of CA moving toward banning (like OR and WA); MBNMS tracking issue
